# Some Facts about the North American Right Whale

The American Right Whale is the most endangered species of whales in the world. There are estimates of only about 400 -350 of them left.

They can grow up to 50 feet and weigh 60 tons. At birth, they can be as long as 15 feet and weigh 2,000 pounds. They are slow-moving at 3 to 7 miles per hour making them vulnerable to boat strikes. In the USA, all boats are required to stay at least 500 yards away from them.

### President Trump is considering banning reduction Fishing by Omega Protein By John Toth

President Trump is considering banning reduction fishing for menhaden in federal waters. The Jersey Coast Anglers Association (JCAA) has been requesting recreational anglers to let President Trump know that we want him to do this through a direct link to the White House. On behalf of our club, I sent a response to the White House urging President Trump to stop this reduction fishing since menhaden is so important to the ocean's ecosystem and it is also an important food source for other species like striped bass and bluefish. Also, without menhaden in our ocean, it negatively impacts the party/charter boat industry as well as tackle shops and marinas.

Omega Protein reduction fleets owned by its parent company, Canadian – owned Cooke Inc., have been taking huge amounts of menhaden within New Jersey's coastal zone for a number of years and even use spotter planes to locate the schools of these fish. On June 23, 2025, a fleet of these reduction boats coming from Virginia spent three days fishing off New Jersey and New York waters.

A member of the Menhaden Defenders that is associated with the JCAA, recently hand delivered a letter to Howard Lutnick, the new Commerce Secretary, explaining why menhaden is so important to the recreational fishing industry and why reduction fishing for it should be banned. I have also recently learned that representatives from Omega Protein and others are also pressuring Mr. Lutnick to allow reduction for this fishery to be continued. I think a decision on this issue will be reached soon. I will update you when it is reached.

### Remembering "Jaws" and its Impact on Sharks By John Toth

I think that everyone who has seen this movie 50 years ago will never forget the duh, duh, duh music before Jaws kills its victim and the red pool of blood that surfaces is unforgettable! People viewing this movie were not only spellbound by it but even terrified of it. I recall a friend of mine who told me that when scientist Matt Hooper, portrayed by Richard Dreyfuss, dove to inspect the damage done to a sunken boat by Jaws and a dead man emerged from it, she screamed and jumped up from her seat. By doing this, the big bag of popcorn she was holding flew up in the air and popcorn landed on everybody around her! The movie was a blockbuster and made a lot of money for Hollywood and its producer, Steven Spielberg.


However, the aftereffect and even unintentional effect of this move was to produce the idea that a dead shark is better that a live one. Throughout the 1970s and 1980s, these ocean predators were vilified as voracious monsters and were drastically overfished so that people could safely swim in the ocean without sharks killing them. I do remember reading that Steven Spielberg even lamented that so many sharks were killed as a result of this movie that he produced.

But the film also ushered in an era of curiosity, inquiry and science to learn more about them. It produced a generation or more of researchers fascinated with these creatures that remained largely unknown. Most shark research was conducted by the U.S. Navy and much of it involved experimenting and testing repellents to prevent shark attacks on sailors. Very little was known about sharks, and the research also sought to understand why they attack people.

Today, thanks to this research, biologists have identified more than 500 shark species. But none has been more closely studied like the species in this film: the Great White shark. Research has helped to dispel its reputation as a man eating machine. This shark can live up to 70 years and it is highly migratory moving along the Eastern seaboard and into the ocean. Researchers using tags on the sharks can track their movements. Yet, while scientists know a lot about these sharks, many mysteries still surround them including their reproductive biology as where do they mate and give birth. "We can tell you where they are going, "Dr. Skomal said, "But it is really hard for us to tell you what they are actually doing."

The movie is loosely based on Frank Mundos, a quirky captain in Montauk with a reputation of hunting and killing sharks. I wanted him to be a speaker at our fishing club. I called his home to set up meeting date. An acquaintance of his took my call and she told me that his speaking fee would be \$400 and that we would have to also set up a hotel room for him since he is coming to see us from Montauk. In the 1970's, \$400 was a lot of money compared to now plus a hotel expense. My club members would not approve such a high fee to have Captain Mundos visit us. I know that Captain Mundos's visit with our club would be very special and memorable given his reputation and the making of Jaws. With him as our speaker, people would be lined up to get in our meeting location and the place would be packed to see and hear what he had to say about Jaws. To this day, I still regret that we did not have this famous captain visit our fishing club and hear him talk about Jaws that we still remember that was made 50 years ago.

# 2025 BIG FISH OF THE YEAR DERBY Rules

- 1. Fish have to be in season to be entered.
- 2. The fish can be caught anywhere, not in just New Jersey's waters.
- 3. The fish entered has to be verified by the boat captain or another club member or at an official weigh station. A picture of the fish is a much-preferred way to verify an entry into the Big Fish contest done by a cell phone or a regular camera. A club member can win more than one Big Fish contest prize.
- 4. Affidavits must be received within 30 days after the fish is caught. Entries for fish caught after 12/15 of a given year must be received by Janaury 15th of the following year.
